

**FAIRFAX COMMUNITY NETWORK LIMITED
"WIN THIS" PROMOTION
TERMS & CONDITIONS**

1. These terms and conditions relate to all promotions featured within the "Win this", "Win giveaways" and "Giveaways" sections of Fairfax Community Network Limited publications, unless the promotion specifies its own unique terms and conditions. Entry into any promotion shall be deemed acceptance of these Terms and Conditions.

THE PROMOTER:

2. The Promoter is Fairfax Community Network Limited ABN 92 007 412 008, Level 5, 1 Darling Island Road, Pyrmont NSW 2009.

PROMOTIONAL PERIOD:

3. Each promotion commences at 00:01 (Melbourne local time) on the release date of the publication in which the promotion is advertised, and concludes at 17:00 (Melbourne local time) on the published close date featured in the relevant publication.

HOW TO ENTER:

4. Entry is open to all Victorian residents. Directors and employees of any company in the Fairfax Media Group and their immediate families (including spouse, parent, child or sibling, whether or not they live in the same house) and printers, suppliers, providers and agencies associated with this promotion are not eligible to enter.
